## **Introduction:**

World Peace Human Rights Organisation has been consistently working towards spreading awareness on human rights, supporting victims of domestic violence, promoting child rights, empowering women, and fighting against human trafficking. In the year 2022-23, the organisation reached thousands of beneficiaries across Sundergarh and nearby regions through various impactful programs.

## **Mission & Vision:**

Our Mission is to safeguard and promote human rights, ensuring equality, justice, and dignity for every individual. We aim to create awareness, provide support to vulnerable communities, and advocate for policies that strengthen human rights.

Our Vision is to build a society free from violence, exploitation, and discrimination, where human rights are respected and every person can live with dignity and peace.

## **Program Activities 2022-23**

### **1. Human Rights Awareness Program**

**Location:** Sundergarh District & nearby villages

**Beneficiaries:** 1,200

This program aimed at spreading knowledge about fundamental human rights and legal protections. Awareness camps, community workshops, and street plays were conducted in villages to empower citizens. Special focus was given to marginalized groups who are often deprived of justice. Beneficiaries learned about mechanisms for legal redressal and how to approach authorities. The program built confidence among rural communities to fight against injustice.



## 2. Domestic Violence Awareness & Support

**Location:** Raurkela Urban & Rural areas

**Beneficiaries:** 850 (women and families)

This initiative provided counselling, legal aid, and awareness sessions to women affected by domestic violence. Meetings with families highlighted the importance of respect, equality, and safe homes. Victims were encouraged to speak up and seek timely support without stigma. Partnerships with local authorities ensured quick action in serious cases. The program not only supported victims but also helped in preventing future violence.



## 3. Child Rights Welfare Program

**Location:** Schools & Child Care Centers, Sundergarh

**Beneficiaries:** 1,500 children

The child rights program worked on protecting children from exploitation and ensuring their education and well-being. School-level workshops taught children about their rights and responsibilities. Awareness drives were held for parents to reduce child labor and school

dropouts. Health checkups and counseling were conducted for vulnerable children. This initiative helped create a safer, healthier, and more supportive environment for children.



#### 4. Women Rights Awareness Program

**Location:** Tangarpali & nearby villages

**Beneficiaries:** 1,000 women

This program focused on empowering women by spreading awareness of their legal and constitutional rights. Training included leadership development, financial literacy, and participation in governance. Women were connected to various government schemes for economic and social support. Group discussions encouraged them to raise their voices against discrimination. The program increased self-confidence and social participation among women.

#### 5. Anti-Human Trafficking Campaign

**Location:** Border villages & vulnerable communities

**Beneficiaries:** 700 individuals

This campaign targeted vulnerable communities to prevent trafficking by educating them about traffickers' tactics. Awareness workshops and distribution of helpline materials were key activities. Rescue and rehabilitation support was provided to victims in collaboration with authorities. Community vigilance groups were formed to ensure safety. As a result, cases of trafficking were reduced in focused areas.



## 6. RTI Act Rights Awareness

**Location:** Community centers, Raurkela

**Beneficiaries:** 600 citizens

This program taught citizens how to use the Right to Information Act to promote transparency and accountability. Training sessions explained step-by-step methods to file RTI applications. Practical case studies showed how RTI can solve local governance issues. Citizens were encouraged to participate in democracy by questioning irregularities. The initiative empowered people to demand good governance and reduce corruption.



## Conclusion:

During 2022-23, our organisation was able to directly benefit more than 5,800 people. With continued support, we aim to expand our outreach in the coming years and strengthen our efforts towards justice, equality, and human dignity.

### **Expansion of Human Rights Awareness**

Strengthen campaigns in rural and urban areas to educate people about their fundamental rights, focusing on marginalized and underprivileged communities.

Provide training in modern skills, entrepreneurship, and digital literacy to empower youth for better employment opportunities and self-reliance.
